A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO SIGN THE DEED OF SALE IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AFFECTING LOT NOS. 1527-B AND 5128-A WITH A TOTAL AREA OF TWELVE THOUSAND TWO HUNDRED FIFTY-ONE (12,251) SQUARE METERS COVERED BY TCT NOS. 17609 AND 17607, RESPECTIVELY, WITH MRS. HERMOGENA LAURENTE-RUBIO, AFTER THE LATTER HAS CLEARED THE LAND OF SQUATTERS, IF ANY.

"WHEREAS, the City Government of Ormoc would like to clear the area within the vicinity of the Livestock Market for the improvement thereon and also, to clear shoreline along Barangay Punta to give way to the prosecution of a reclamation project;

"WHEREAS, this august Body has appropriated the amount of P147,500.00 per Appropriation-Ordinance No. 85-13 to be taken from out of the 1984 Unappropriated Surplus of the Infrastructure Fund to be made available for the purchase of the land of Mrs. Hermogena Laurente-Rubio for Lot Nos. 1527-B and 5128-A with a total area of Twelve Thousand Two Hundred Fifty-One (12,251) sq. m. covered by TCT Nos. 17609 and 17607, respectively, situated at Barangay Linao, for exchange of titled lot owners at the Livestock Market and along Barangay Punta shoreline;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Bandalan;

"RESOLVED, to authorize the Honorable Acting City Mayor, to sign the Deed of Sale in behalf of the City Government of Ormoc affecting lot Nos. 1527-B and 5128-A with a total area of Twelve Thousand Two Hundred Fifty-One (12,251) sq. m. covered by TCT Nos. 17609 and 17607, respectively, with Mrs. Hermogena Laurente-Rubio, after the latter has cleared the land of squatters, if any;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Veterinarian and Mrs. Hermogena L. Rubio, all in Ormoc City;
