PAMBANSA OF THE PROVINCE OF LEYTE TO SUPPORT THE PENDING
BILL OF MP ROBERTO MONTELIBANO (KBL) NEGROSS OCCIDENTAL
FOR A ROLL BACK OF INTEREST RATE TO SUGAR PLANTERS FROM
36% to 8% IN THE RE-STRUCTURING OF SUGAR CROP LOANS.
