RESOLUTION NO. 1729

A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE GANEFOL COMMISSION, METRO MANILA, THROUGH THE REGIONAL DIRECTOR, TAGLOHAN CITY, TO GRANT SPECIAL PERMIT TO HOLD A 3-DAY "PINTAKASI" (APRIL 18, 19, AND 20, 1985) AT THE VALENCIA SPORTS COMPLEX, ORMOG CITY SPONSORED BY THE BOARD OF DIRECTORS OF THE MUNICIPAL MAYORS LEAGUE OF LEYTE, PROVIDED THAT THEY COMPLY WITH RULES AND REGULATIONS OF SAID COMMISSION.

"WHEREAS, this august body is in receipt of the communication dated 27 March 1985 of Honorable Municipal Mayor of Abatagan Leyte, concurrent President, 1st District and Senior Member, Board of Directors, NML requesting possible indorsement to the Philippine Ganefol Commission, Metro Manila, to grant Special Permit to the Valencia Sports Complex, Ormoc City to hold a 3-day "Pintakasi" on April 18, 19, and 20, 1985;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by Kagawad Bandalan;

"RESOLVED, to earnestly request the Philippine Ganefol Commission, Metro Manila, through the Regional Director, Taglohan City to grant Special Permit to the Valencia Sports Complex, Ormoc City, to hold a 3-day "Pintakasi" on April 18, 19, and 20, 1985, Sponsored by the Board of Directors, Municipal Mayors League of Leyte, provided, they comply with the rules and regulations of said Commission;
