RESOLUTION NO. 1731

A RESOLUTION REQUESTING THE CITY ENGINEER TO DIRECT THE
CITY GEODETIC ENGINEER DARLITO PAREJA TO CONDUCT A
DELINEATION SURVEY OF LOT NO. 6518-PART WITH AN AREA
OF 5,000 SQUARE METERS WHICH IS THE SCHOOL SITE OF
BARANGAY LICUMA.

"WHEREAS, the Sangguniang Pambarangay of Licuma in its
Resolution No. 2, c.s., alleges that said barangay has acquired
by purchase a portion of Lot No. 6518-part with an area of 5,000
square meters, where the temporary school building is constructed;

"WHEREAS, the boundaries of the said school site is not delinea-
ted yet for the reason that up to now no survey has been made o f
the said land, and that, the present portion occupied as school site
is merely based on an estimate;

"NOW, THEREFORE, on motion of Kagawad Alfaro, seconded b y
Kagawad Hermosilla; be it

"RESOLVED, to request the City Engineer to direct the City
Geodetic Engineer Darlito Pareja to conduct a delineation survey
