A RESOLUTION TO ENDORSE FAVORABLY RESOLUTION NO. 72-85 SERIES 1985 OF THE SANGGUNIANG PANLUNGSO OF OROQUIETA AMENDING SECTION 173 (3) OF THE LOCAL GOVERNMENT CODE THAT ALL COMPONENT CITIES SHALL BE ENTITLED TO ELECT EIGHT (8) SANGGUNIANG MEMBERS THE SAME WAY AS PROVIDED IN SECTION 146 (1) OF THE LOCAL GOVERNMENT CODE FOR THE SANGGUNIANG BAYAN.

"WHEREAS, the Honorable Sangguniang Panlungsod of Oroquieta has furnished us for our favorable endorsement a copy of its Resolution No. 72-85 series 1985, to amend Section 173 (3) of the Local Government Code that all component cities shall be entitled to elect eight (8) Sangguniang Panlungsod Members the same way as provided in Section 146 (1) of a Local Government Code for the Sangguniangan Bayan;

"NOW, THEREFORE, on motion of Kagawad Besabella seconded by Kagawad Mendola; be it

"RESOLVED, to endorse favorably Resolution No. 72-85 series 1985 of the Sangguniang Panlungsod of Oroquieta, to amend Section 173 (3) of the Local Government Code that all component cities shall be entitled to elect eight (8) Sangguniang Panlungsod Members the same way as provided in Section 146 (1) of the Local Government Code for the Sangguniangan Bayan;

"RESOLVED, FURTHER, to furnish a copy of this Resolution each to His Excellency President Ferdinand E. Marcos, Malacañang, the Honorable Speaker, Batasang Pambansa, both of Metro Manila, and the Honorable Sangguniang Panlungsod of Oroquieta, Oroquieta City;
