

RESOLUTION NO. 1737

A RESOLUTION TO ENDORSE FAVORABLY RESOLUTION NO. 2243
OF THE SANGGUNIANG PANLUNGSOD NG LUCENA STRONGLY
SUPPORTING RESOLUTION NO. 183 AUTHORED BY MP MARCELO
B. FERNAN, SETTING FORTH THAT FAMILY HOMES BE INCLUDED
IN THE EXEMPTION FROM TAXATION UNDER THE CONSTITUTION
AND RESPECTFULLY ENDORSING SAME TO HIS EXCELLENCY PRE-
SIDENT FERDINAND E. MARCOS AND ALL MAMBABATAS PAMBANSA
FOR APPROVAL.

"WHEREAS, the Honorable Sangguniang Panlungsod ng Lucena
has furnished for our favorable endorsement a copy of its Re-
solution No. 2243 Series 1984 authored by MP MARCELO B. FERNAN,
setting forth that family homes be included in the exemption
from taxation under the Constitution and respectfully endorsing
same to His Excellency, President Ferdinand E. Marcos and all
Mambabatas Pambansa for approval;

"NOW, THEREFORE on motion of Kagawad Besabella, seconded
unanimously by all the other Mga Kagawad present; be it

"RESOLVED, to endorse favorably Resolution No. 2243 of the
