RESOLUTION NO. 1738

A RESOLUTION TO ENDORSE FAVORABLY RESOLUTION NO. 2288
OF THE SANGGUNIANG PANLUNGSOD NG LUCENA, EARNESTLY
REQUESTING THE BATASANG PAMBANSA, THRU THE HONORABLE
PRIME MINISTER AND HONORABLE SPEAKER TO INCLUDE IN
THE LOCAL GOVERNMENT CODE BY WAY OF AMENDMENT OR
SUPPLEMENT A PROVISION MANDATING THE ADDITION OF
TWO (2) MORE ELECTIVE OFFICIALS IN COMPONENT CITY
OR CITIES AS ITS REPRESENTATIVE TO THE SANGGUNIANG
PANLALAWIGAN OF THE PROVINCE TO WHICH TERRITORIAL
JURISDICTION THE COMPONENT CITY OR CITIES BELONG,
TO BE ELECTED BY THE REGISTERED VOTERS OF THE CITY
OR CITIES CONCERNED

"WHEREAS, the Sangguniang Panlungsod ng Lucena has fur-
nished us for our favorable endorsement Resolution No. 2288,
series 1985 requesting the Batasang Pambansa, thru the Hono-
rable Prime Minister and Honorable Speaker to include in the
Local Government Code by way of amendment or supplement a pro-
vision mandating the addition of two (2) more elective offi-
cials in component city or cities as its representative to
the Sangguniang Panlalawigan of the province to which terri-
torial jurisdiction the component city or cities belong, to
be elected by the registered voters of the city or cities
concerned;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded
by all the other Kagawads present; be it

"RESOLVED, to endorse favorably Resolution No. 2288 series
1985 of the Sangguniang Panlungsod ng Lucena, earnestly re-
questing the Batasang Pambansa, thru the Honorable Prime Mi-
nister and Honorable Speaker to include in the Local Govern-
ment Code by way of amendment or supplement a provision man-
dating the addition of two (2) more elective officials in com-
ponent city or cities as its representative to the Sangguni-
ang Panlalawigan of the province to which territorial jurisdic-
tion the component city or cities belong, to be elected by the
registered voters of the city or cities concerned;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the Honorable Prime Minister, the Honorable Speaker,
both of Batasang Pambansa, Metro Manila, the Honorable Sang-
guniang Panlungsod ng Lucena, Lucena City;
