A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY

ORMOC A CONTRACT WITH WOOLBRIGHT CORPORATION FOR
THE DRILLING OF THE FOURTH WELL SITUATED AT BA-
RANGAY DONGHOL (NADONGHOLAN), ORMOC CITY AS APPROVED
BY THE PBAC IN ITS UNNUMBERED RESOLUTION DATED
MARCH 13, 1985.

"WHEREAS, the Honorable Acting City Mayor in his letter of
April 11, 1985 has requested for authority to sign for and in
behalf of the city of Ormoc a contract with Woolbright Corpora-
tion for the drilling of the fourth well situated at Nadongholan,
Barangay Donghol, Ormoc City, the details of the project proposals
are hereto attached and accepted by the PBAC Committee thru its
Unnumbered Resolution of March 13, 1985;
