RESOLUTION NO. 1742

A RESOLUTION DIRECTING DR. ROGELIO G. MARSON, CITY
HEALTH OFFICER AND DR. AMANDO APODERADO, CITY VETE-
RINARIAN, TO CONDUCT A DAILY MEAT INSPECTION AND
INVESTIGATION REGARDING THE ALLEGED PEDDLING OF
REJECTED MEAT CALLED "MEJORAS" WHICH ALLEGEDLY
INCLUDE CATS & MICE MEAT, BEING SOLD WITHIN THE
VICINITY OF PUBLIC MARKET OF ORmoc CITY; REQUEST-
ING FOR AN IMMEDIATE REPORT THEREON;

"WHEREAS, numerous complaints have been aired regarding
alleged peddling of rejected meat called "Mejoras" which in-
clude cats and mice within the vicinity of the Ormoc City pub-
lic market posing danger to the health of the consuming public;

"NOW, THEREFORE, on motion of Kagawad Besabella seconded
jointly by Mga Kagawad Mendola and Alfaro; be it

"RESOLVED, to earnestly direct Dr. Rogelio G. Marson,
City Health Officer and Dr. Amando Apoderado, City Veterina-
rian, to conduct a daily meat inspection and investigation on
the alleged peddling of reject meat called "Mejoras" which in-
clude cats and mice meat being sold within the vicinity of the
public market and requesting a report thereon as early as
possible;

"RESOLVED, FURTHER, that the Chief of Police be also di-
rected to send policemen to the area and apprehend these err-
ing vendors;

"RESOLVED FURTHERMORE, to furnish a copy of this resolu-
tion each to the City Health Officer, the City Veterinarian,
and the Market Master, Public Market, all in Ormoc City;

"CARRIED UNANIMOUSLY."
