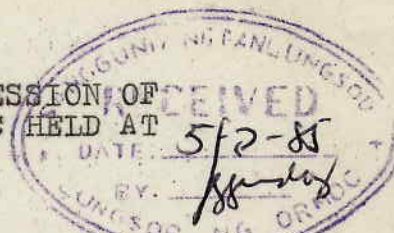

RESOLUTION NO. 1744

A RESOLUTION REQUESTING THE REGIONAL DIRECTOR, PHILIPPINE GAMEFOWL COMMISSION, TACLOBAN CITY FOR AN AUTHORITY OF THE MANAGER, NADONGHOLAN COCKPIT TO HOLD A 3-DAY "PINTAKASI" ON JUNE 24, 25, AND 26, 1985, TO BE SPONSORED BY THE ORMOC SOUTH DISTRICT, BOY SCOUT OF THE PHILIPPINES.

"WHEREAS, the Secretary to the City Mayor in his capacity as BSP Chairman, Ormoc South District in his communication of April 22, 1985 has requested a resolution for a 3-day 'Pintakasi' on June 24, 25, and 26, 1985, the proceeds derived from it will be used to finance the Boy Scout activities of said district;
