RESOLUTION AMENDING RESOLUTION NO. 1611, CURRENT SERIES, AUTHORIZING THE HONORABLE ACTING CITY MAYOR, IN BEHALF OF THE CITY OF ORMOC, TO SIGN A DEED OF ABSOLUTE SALE OF THE ROAD-RIGHT-OF-WAY OF THE CONUL FAMILY AFFECTING PORTIONS OF LOT NOS. 1364 WITH AN AREA OF 4,550 SQUARE METERS AND 1365 WITH AN AREA OF 2,370 SQUARE METERS, AT A PRICE PEGGED AT \$20,830.50, AS RECOMMENDED BY THE CITY AUDITOR IN CONNECTION WITH THE RECOMMENDATION OF THE CITY ENGINEER AND PER APPRAISAL OF THE CITY ASSESSOR'S OFFICE.
