RESOLUTION NO. 1746

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY
MAYOR TO ALLOW OPERATION OF ADDITIONAL 30 UNITS
OF MOTORIZED TRICYCLES IN THE CITY OF ORMOC

"WHEREAS, Kagawad Bandalan in his capacity as Chairman on Transportation has requested for an additional 30 units motorized tricycles to operate in the City of Ormoc to meet the demands and satisfaction of the commuters or riding public in the different points of the City and barangays;

"WHEREAS, it has been noted that the present number of motorized tricycles operating in the City could hardly cope up with the needs of the riding public considering the increase in population in the City of Ormoc;

"WHEREAS, Barangays near the City, particularly those without transportation operators, bewail the situation that during night time and in cases of emergency no transportation facility is available; that it becomes imperative, therefore, that urban/rural Barangays near the City can avail of motorized tricycles services;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded jointly by Mga Kagawads Mendola and Hermosilla; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to allow the operation of additional 30 units motorized tricycles in the City of Ormoc;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Ministry of Land Transportation, Ormoc Field Office and the Station Commander, Ormoc City INP, all in Ormoc City;

"CARRIED UNANIMOUSLY."
