RESOLUTION NO. 1747

A RESOLUTION STRONGLY ENDORSING RESOLUTION NO. 68 OF THE  
SANGGUNIANG PANLUNGSOD NG SAN JOSE REQUESTING AMONG  
OTHERS TO REPEAL THE PROVISION OF SECTION 15 OF BATAS  
PAMBANSA NO. 337.

"WHEREAS, the Honorable Sangguniang Panlungsod of San Jose has  
forwarded to us for favorable indorsement and support its Resolution  
no. 68 to repeal Section 15 of Batas Pambansa No. 337, otherwise known  
as the "Local Government Code;

"WHEREAS, this particular section 15 provides that the province,  
through the Provincial Governor, shall see to it that every component  
city within its territorial jurisdiction acts within the scope of its  
assigned powers and functions thus negates the principle of political  
autonomy upon which the creation and/or existence of cities is based;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded unanimously  
by all the rest of Mga Kagawads present; be it

"RESOLVED, to strongly endorse Resolution No. 68 of the Sangguniang  
Panlungsod of San Jose to repeal the provision of Section 15 of Batas  
Pambansa No. 337;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the  
Batasang Pambansa through the Batasan Committee on Division of Laws, all  
Assemblymen of Region 8, and the Honorable Sangguniang Panlungsod of San  
Jose;
