RESOLUTION NO. 1748

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER OF ENERGY THROUGH THE PHILIPPINE NATIONAL OIL COMPANY WHO HAS JURISDICTION OVER OUR FOREST AND ALSO, THE TRIPARTITE COMMITTEE ON SECURITY THROUGH THE PROVINCIAL COMMANDER IN HIS CAPACITY AS CHAIRMAN, TO EXERT MORE EFFORTS IN STAMPING OUT THE ILLEGAL CUTTING OF TREES IN ORMOG CITY.

"WHEREAS, some Association of Barangay Council's Presidents have expressed their apprehension over the unabated logging operations in the province, more particularly in the watershed area covered by the PNOC reservation;

"WHEREAS, no less than our Waterworks Supervisor, expressed his fears that the water supply of Ormoc City will be seriously affected as it has already been affected, by the wanton cutting of trees within the watershed area;

"WHEREAS, it cannot be denied that the uncontrolled cutting of trees severely affects the ecological balance and weather conditions of the region;

"WHEREAS, despite of the organization of the Tripartite Security Committee, committed to the PNOC preservation of the watershed, still unabated logging goes on unchecked;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Mendola; be it

"RESOLVED, to earnestly request the Honorable Minister of Energy through the Philippine National Oil Company, based in Tugonon, Ormoc City who has jurisdiction over our forest and also, the Tripartite Security Committee through the Provincial Commander in his capacity as Chairman, to exert more efforts in stamping out the illegal cutting of trees in Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Geronimo Z. Velasco, Minister of Energy, Metro Manila, Col. Anacleto P. Arque, Jr., Provincial Commander, Headquarters Leyte Constabulary/INP Commands, Bonifacio St., Port Area, Tacloban City, Capt. Pedro Pates, 352nd PC CO. and Maj. Alfredo T. Quibin, Ormoc City, INP, both of Ormoc City;
