Office to fill up with gravel and sand and connect Acasia Street  
located in Rufemelda Village, Purok Gumamela to Narra Street;

closed to traffic with plenty of pockmark during dry season and  
muddy during rainy season with a distance of only 10 meters away  
to Narra Street as its outlet, and 100 meters away from the high-  
way through a narrow private road thus creating fear to the resi-  
dents in case of conflagration;
