A RESOLUTION AMENDING RESOLUTION NO. 1744, CURRENT SERIES, SO AS TO CHANGE THE DATE OF THE "PINTAKASI" FROM JUNE 24, 25, & 26, 1985 TO JUNE 18, 19, & 20, 1985 AS REQUESTED BY THE ORMOC DISTRICT SCOUTING COMMITTEE, SUBJECT HOWEVER, TO THE RULES AND REGULATIONS OF THE PHILIPPINE GAMEFOWL COMMISSION.
