RESOLUTION NO. 1755

A RESOLUTION REQUIRING THE OFFICE OF THE LOCAL CIVIL REGISTRAR, ORMOC CITY TO GIVE THIS AUGUST BODY THEIR LEGAL BASIS IN REFUSING TO HONOR THE OATH OF AFFIDAVITS ADMINISTERED BY THE CLERK OF COURT OF THE MUNICIPAL TRIAL COURT IN CITIES, ORMOC CITY.

"WHEREAS, this august Body is aware of the fact that the Local Civil Registrar of this city has refused to honor oath of affidavits administered by the Clerk of Court of the Municipal Trial Court in Cities, in Ormoc City;

"WHEREAS, low wage earners especially from the rural areas can not afford to pay their oath of affidavits administered by a private notary public;

"WHEREAS, the signature of our Clerk of Court in Cities can greatly help minimize expenses;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly by Mga Kagawad Larrazabal and Fiel, be it

"RESOLVED, to require the Office of the Local Civil Registrar, Ormoc City to give this august Body the legal basis of their office in refusing to honor the oath of affidavits administered by the Clerk of Court of the Municipal Trial Court in Cities, in Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Civil Registrar, and the Clerk of Court, Municipal Trial Court in Cities, both of Ormoc City;

"CARRIED UNANIMOUSLY."
