RESOLUTION NO. 1760

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO EXCHANGE PORTION OF CITY LOTS AT THE RELOCATION SITE AT BARANGAY LINAO WITH THAT OF THE TITLED LANDOWNERS AT BARANGAY ALEGRIA FOR USE AS SLAUGHTERHOUSE AND LIVESTOCK MARKET. THE CITY WILL EXCHANGE DOUBLE THE AREA OF THE TITLED LANDOWNERS AND TO APPROPRIATE FURTHER THE AMOUNT OF P3,000.00 TO COVER THE SUBDIVISION SURVEY COST.

"WHEREAS, this august Body is in receipt of the joint petition of the titled landowners, residing inside the slaughterhouse which lots are intended for use as slaughterhouse and Livestock Market;

"WHEREAS, this august Body was enlightened of the manifestation or reason of Kagawad Mendola in his capacity as Chairman on Public Properties of the validity of the transaction that the residents concerned will give way if some of their requests are granted;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Alfaro and Hermosilla; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to exchange the land owned by the City Government at the relocation site at Barangay Linao with that of the titled Landowners at Barangay Alegria which is intended as slaughterhouse and Livestock Market wherein the city government will give or exchange two times bigger, or double the area of the titled landowners and in addition the city will further appropriate P3,000.00 for subdivision survey costs.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Veterinarian, and the residents concerned of Barangay Alegria, all in Ormoc City;

"CARRIED UNANIMOUSLY."
