RESOLUTION No. 1763

A RESOLUTION AUTHORIZING HIS HONOR, ACTING CITY MAYOR TO ACCEPT THE DONATION OF BARANGAY CAGBUHANGIN, STREETLIGHTING MATERIALS CONSISTING OF SEVERAL LIGHTING FIXTURES TALLING 250 WATTS TO BE INSTALLED ALONG THE ORMOC-TACLOBAN ROAD WITHIN ITS JURISDICTION SUBJECT HOWEVER TO RESOLUTION NO. 1149, SERIES OF 1982.
