RESOLUTION NO. 1764

A RESOLUTION EARNESTLY REQUESTING HONORABLE SALVADOR ESCUDERO III, MINISTER OF AGRICULTURE AND FOOD AND MR. MIKE ZOSA, PRESIDENT, PHILPHOS/PASAR ASSOCIATION TO ALLOCATE ORMOC CITY SUFFICIENT FERTILIZER STOCK ESPECIALLY GRADES 14-14-14, 15-15-15 AND 16-20-0.

"WHEREAS, Ormoc City farmers are badly hit by lack of fertilizer in the market especially now that it is planting season;

"WHEREAS, if the farmers' plight are not attended to immediately, there will be economic slump in Ormoc City, most especially in the sugarcane, rice and other industries, the only means of livelihood of majority of our people in Ormoc;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, unanimously seconded by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request Honorable Salvador Escudero III, Minister of Agriculture and Food and Mr. Mike Zosa, President, PHILPHOS/PASAR Association to allocate Ormoc City sufficient fertilizer stock especially Grades 14-14-14, 15-15-15 and 16-20-0 for the benefits of the farmers of Ormoc City and neighboring municipalities;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang; Honorable Salvador Escudero III, Minister of Agriculture and Food, Quezon City; Mr. Mike Zosa, President, PHILPHOS/PASAR Association, 6th Floor, Glass Tower Building, Alvarado Street, Legaspi Village, Makati; and Honorable Roberto Benedicto, PHILSUCOM, Chairman, all of Metro Manila; Honorable Benjamin Romualdez, Governor of Leyte, Capitol Building, Tacloban City, the Managers PASAR and PHILPHOS both of Isabel, Leyte; the Officer In-Charge, Ministry of Agriculture and Food, Ormoc City.
