RESOLUTION NO. 1766

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO ENTER INTO AN AGREEMENT WITH THE MINISTRY OF PUBLIC WORKS AND HIGHWAYS, REPRESENTED BY ITS HEAD CIVIL ENGINEER (RESIDENT ENGINEER), WEST LEYTE ROAD IMPROVEMENT PROJECT, BASED IN LEYTE, TO ALLOW THEM TO CONSTRUCT BUILDINGS AT THE CITY GOVERNMENT LOT IN BARANGAY VALENCIA, HIGH SCHOOL SITE, PROVIDED, THAT THE BUILDING AND IMPROVEMENTS THEREON SHALL BE TURNED-OVER TO THE CITY GOVERNMENT AFTER THE COMPLETION OF THE PROJECT (WEST LEYTE ROAD IMPROVEMENT, PACKAGE I).

"WHEREAS, the Acting City Mayor has endorsed to this august Body, for appropriate action the communication of Engr. Norberto V. Lorenzo, Head Civil Engineer (Resident Engineer), West Leyte Road Improvement Project, Ministry of Public Works & Highways, requesting for the temporary use of part of the lot of the Ormoc City High School, Barangay Valencia, Ormoc City where they intend to construct the Project Manager's Office and Engineer's Bunkhouse;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by all the other Mga Kagawad present; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to enter into an agreement with the Ministry of Public Works & Highways, represented by its Head Civil Engineer (Resident Engineer), West Leyte Road Improvement Project, based in Leyte, to allow them to construct buildings at the City Government lot in Barangay Valencia, High School site, Provided, That the building and improvements thereon shall be turned-over to the City Government after the completion of the project (West Leyte Road Improvement, Package I);

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Minister, Ministry of Public Works & Highways, Metro Manila; the Regional Director, Ministry of Public Works & Highways, Region VIII, Candahug, Palo, Leyte; the Head Civil Engineer (Resident Engineer), West Leyte Road Improvement Project, Ministry of Public Works & Highways and the City Engineer, both of Ormoc City.
