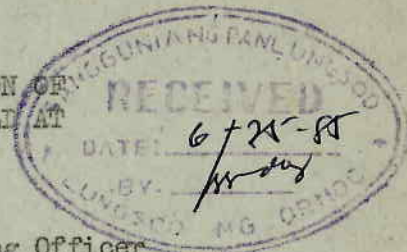

RESOLUTION 1773

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO ALLOW
OPERATION OF ADDITIONAL FORTY (40) UNITS OF MOTORIZED TRICYCLES
IN THE CITY OF ORMOC.

WHEREAS, the Honorable Acting City Mayor has requested Forty
(40) units more additional motorized tricycles to serve this year
the transportation needs of our barangays most especially the in-
creasing number of students and the reduced number of PUB vehicles
for short distances;
