RESOLUTION NO. 1779

A RESOLUTION STRONGLY AND EARNESTLY ENDORSING THE PROMOTION OR APPOINTMENT OF MR. VICENTE T. SUAZO, JR., PRESENTLY PORT MANAGER, PPA OF DAVAO CITY, TO THE POSITION OF ASSISTANT GENERAL MANAGER FOR OPERATIONS, PHILIPPINE PORTS AUTHORITY.

"WHEREAS, knowledge has reached this distinguished Body that with the untimely demise of Col. Eustaquio Baclic, Jr., former General Manager of the Philippine Ports Authority, and the promotion of Col. Maximo Dumlaog to succeed him as General Manager (Officer In-Charge), a vacancy in the position of Assistant General Manager of the Philippine Ports Authority has thus been created;

"WHEREAS, Vicente T. Suazo, Jr., presently Port Manager of the Philippine Ports Authority assigned in Davao City, on the basis of his signal achievements, sterling qualities, consecration to duty, and above all, seniority, is abundantly qualified to fill in the now vacant position as Assistant General Manager for Operations;

"WHEREAS, for no cause or reason shall this Body feel reticent or diffident in recommending Vicente T. Suazo, Jr., on the contrary, we do it with all vehemence and earnestness of purpose as we are all of the firm conviction that by appointing him to such a position with his assiduity for work and devotion to duty he will acquit himself creditably and will further enhance the already known remarkable achievements of the PPA to the credit of the Government of the Republic of the Philippines;

"WHEREAS, a recapitulation of the credentials of Mr. Vicente T. Suazo will convincingly show his aptitude, personal attributes, undisputed qualifications for the position applied for: Upon the creation of the Philippine Ports Authority by P.D. 505 on August 1, 1975, he was appointed as First Manager of the Port of Cebu and in 1983, he was transferred to Davao as Port Manager, a position he still holds, verily he can be considered as one of the pioneers in Port Management; previous to this assignments, he occupied various positions as Port Operations Officer, Ports Operation Specialist, and Assistant Director;

"WHEREAS, Vicente T. Suazo, Jr. has made deep studies, and made valuable recommendations regarding the security and intelligence in connection with the containerization on Ports; has attended training courses on Port Management sponsored by the UNCTAD/STD in Kuala Lumpur, and in Singapore; he has been the Philippine Delegate to the 8th Asean Port Authority meeting in Kuala Lumpur in 1982, and has received citations and commendations from Mr. C. H. Gladwell Organization and Financial consultant, Urwick

International LTD in September 19, 1972;

"WHEREFORE, on motion of Kagawad Besabella, unanimously seconded by all the other Mga Kagawads present; be it






