A RESOLUTION APPROVING RESOLUTION NO. 2, SERIES OF 1985 OF THE SANGGUNIANG PAMBARANGAY OF MILAGRO APPROPRIATING THE AMOUNT OF P500.00 FROM ITS 10% BARANGAY SHARE TO BE MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD RICARDO MANIQUEZ.
