RESOLUTION NO. 1781

A RESOLUTION REQUESTING THE REGIONAL DIRECTOR, MINISTRY OF LAND TRANSPORTATION, TACLOBAN CITY TO AUTHORIZE THE CITY HEALTH OFFICER, DOCTORS OF THE ORMOC DISTRICT HOSPITAL OR ANY OTHER GOVERNMENT PHYSICIAN TO CONDUCT PHYSICAL EXAMINATION ON APPLICANTS FOR RENEWAL OF LICENSES IN ORMOC CITY.

"WHEREAS, this august Body has reliably been informed that Dr. Reynaldo Esquivel, is said to be a duly physician recognized by the office of the Regional Director, Ministry of Land Transportation authorized to conduct physical examination on applicants as a requirement for renewal of their licenses;

"WHEREAS, this august Body requests that government Doctors, like the City Health Officer and Doctors at the Ormoc District Hospital be allowed to conduct physical examination on applicants for renewal of Driver's Licenses, and that their examinations be recognized by the Bureau of Land Transportation Licensing Office at Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Alfaro, unanimously seconded by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Regional Director, Ministry of Land Transportation, Tacloban City, to authorize the City Health Officer, the Doctors of the Ormoc District Hospital or any other government physician to conduct physical examination of applicants securing renewal of their licenses in Ormoc City and that, their examination results be recognized by the said Office;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Ministry of Land Transportation, Tacloban City, the Bureau of Land Transportation Field Office, the City Health Officer, the Chief of Hospital, Ormoc District Hospital, the MECS' Physician, all drivers concerned, all in Ormoc City;
