RESOLUTION NO. 1796

A RESOLUTION TO DECLARE A PORTION OF CARLOS TAN STREET FROM CORNER REAL STREET TO A PORTION OF MABINI STREET UP TO THE CORNER OF OSMEÑA STREET, AS A ONE-WAY TRAFFIC FOR MOTOR VEHICLES FROM 7:30 A.M. TO 12:30 P.M. DURING SCHOOL DAYS.

"WHEREAS, the Directress of Saint Paul's School has requested the declaration of portion of Carlos Tan Street from corner Real Street to a portion of Mabini Street up to the corner of Osmeña Street, as a one-way vehicular traffic from 7:30 a.m. to 12:30 p.m. during school days (Monday to Friday) "

"WHEREAS, the making of such portions as one-way traffic for motor vehicles will redound not only for the safety of the pupils of Saint Paul's School but also as a protection to life and limb of the residents therein;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded jointly by Mga Kagawad Mendola, Alfaro and Hermosilla; be it

"RESOLVED, to declare a portion of Carlos Tan Street from corner Real Street to a portion of Mabini Street up to the corner of Osmeña Street, as a one-way traffic for motor vehicles from 7:30 a.m. to 12:30 p.m. during school days (Monday to Friday); Provided further that the sign board shall be removed after 12:30 P.M.;
