RESOLUTION NO. 1798

A RESOLUTION CONCURRING WITH RESOLUTION NO. 2400, SERIES OF 1985 OF THE SANGGUNIANG PANLUNGSOD OF LUCENA STRONGLY SUPPORTING AND ENDORSING RESOLUTION NO. 67, SERIES OF 1985 OF THE SANGGUNIANG PANLUNGSOD OF OZAMIZ REQUESTING AMONG OTHERS THE HONORABLE SPEAKER OF THE BATASANG PAMBANSA TO AMEND THE PROVISION OF ARTICLE 350 OF THE CIVIL CODE OF THE PHILIPPINES REGARDING THE CONSTITUTION OF FAMILY HOME BY INCREASING ITS VALUE FROM ₱40,000.00 TO ₱100,000.00

"WHEREAS, the Honorable Sangguniang Panlungsod ng Lucena has furnished us for our favorable concurrence a copy of its Resolution No. 2400 Series of 1985 strongly supporting and endorsing to the Honorable Speaker of the Batasang Pambansa Resolution No. 67, series of 1985 of the Sangguniang Panlungsod of Ozamiz requesting the Batasang Pambansa, thru the Honorable Speaker to recommend, the amendment of Article 350 of the Civil Code of the Philippines, increasing the value for family home from FORTY THOUSAND (₱40,000.00) PESOS considering the devaluation of the Philippine Peso to ₱100,000.00;
