RESOLUTION NO. 1803

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR AND THE CITY ENGINEER TO APPLY FOR A PERMIT IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE BUREAU OF MINES AND GEO-SCIENCES, CEBU CITY FOR THE EXTRACTION OF SAND AND GRAVEL IN ANY SOURCE AND RIVER BEDS WITHIN THE CITY OF ORMOC FOR THE USE OF THE CITY GOVERNMENT.

"WHEREAS, we have been informed that concessionaires or the landowners are prohibiting the City Engineer's equipment to haul sand and gravel on the supposed hauling site along river beds;

"WHEREAS, it is but imperative to authorize the Acting City Mayor and the City Engineer to apply a permit with the Bureau of Mines and Geo-Sciences to extract sand and gravel in any source and river beds within the territorial jurisdiction of Ormoc City for the smooth prosecutions of various government projects;

"NOW, THEREFORE, on motion of Kagawad Bandalan, unanimously seconded by all the other Mga Kagawad presents; be it

"RESOLVED, to authorize the Honorable Acting City Mayor and the City Engineer to apply for a permit, in behalf of the City Government of Ormoc with the Bureau of Mines and Geo-Sciences, Cebu City to extract sand and gravel in any source and river beds within the territorial jurisdiction of Ormoc City for city government's use;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Bureau of Mines and Geo-Sciences, Cebu City, and the City Engineer, Ormoc City;

"CARRIED UNANIMOUSLY."
