- A RESOLUTION ADOPTING RESOLUTION NO. 3885, SERIES 1985 OF THE SANGGUNIANG PANLUNGSOD OF LAOAG EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS TO AMEND SOME OF THE PROVISIONS OF PD 1752, OTHERWISE KNOWN AS THE "HOME DEVELOPMENT MUTUAL FUND LAW" (Pag-IBIG) MAKING THE LAW NOT MANDATORY (VOLUNTARY MEMBERSHIP) AND REQUESTING THE REPAYMENT OF THE CONTRIBUTIONS THEY HAVE MADE.

"WHEREAS, we have received Resolution No. 3885, s. 1985 of the Sangguniang Panlungsod of Laoag earnestly requesting His Excellency President Ferdinand E. Marcos to amend some of the provisions of PD 1752, otherwise known as the 'Home Development Mutual Fund Law' (Pag-IBIG) making the law not mandatory (voluntary membership) and requesting the repayment of same;
