RESOLUTION NO. 1805

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER OF PUBLIC WORKS AND HIGHWAYS TO CONVERT SIMANGAN-DOLORES-MILAGRO-TUNGONAN ROAD (15.690) KMS.); MILAGRO-LAKE IMELDA-LIBERTY ROAD (23.5 KMS.); AND CANBANTUG-KABINGTAN ROAD (8.40KMS.) INTO NATIONAL ROADS.

"WHEREAS, we have received communication from the City Engineer requesting passage of a resolution for the conversion into National Roads the following barangay roads;

1. Simangan-Dolores-Milagro-Tungonon Road (15.690 kms.)
This road connects to another national road at Kananga;
2. Milagro-Lake Imelda-Liberty Road (23.5 kms.)
This road leads to a national park and tourist spot - Lake Imelda - and also connects to the Lake Imelda Circumferential National Road and eventually connect Burauen-Albuera Road; and
3. Canbantug-Kabingtang Road (8.40 kms.)
This road will eventually connect the town of Jaro, Leyte.

"WHEREAS, the City Government would stand to benefit from this conversion;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded by Kagawad Torrevillas; be it

"RESOLVED, to earnestly request the Honorable Minister of Public Works and Highways to convert Simangan-Dolores-Milagro-Tungonon Road (15.690 kms.); Milagro-Lake Imelda-Liberty Road (23.5 kms.); and Canbantug-Kabingtang Road (8.40 kms.) into National Roads;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Public Works & Highways, Manila; the Regional Director, Ministry of Public Works & Highways, Candahug, Palo, Leyte; and the City Engineer, Ormoc City;
