Negros Occidental;

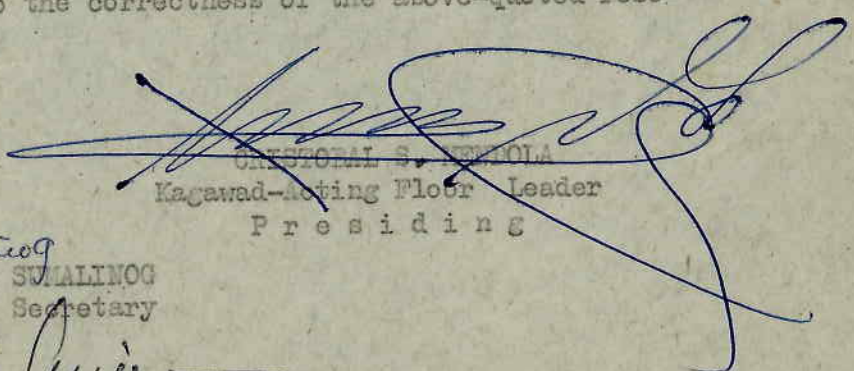
"NOW, THEREFORE, on motion of Kagawad Alfaro, seconded by all

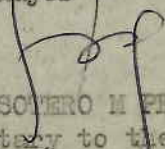
