RESOLUTION NO. 1812

A RESOLUTION REQUESTING GENERAL PEDRO G. DUMOL ADMINISTRATOR
NATIONAL ELECTRIFICATION ADMINISTRATION, TO CONFIRM THE AP-
POINTMENT OF MR. EMILIANO B. CODERA, OFFICER-IN-CHARGE, LEYECO
V AS REGULAR GENERAL MANAGER OF LEYECO V.

"WHEREAS, considering the viable status of the Leyte V Elec-
tric Cooperative (LEYECO V), and the need to maintain such viabi-
lity especially on its financial aspects, it is necessary that the
Cooperative hire a regular General Manager;

"WHEREAS, continued viability of the LEYECO V will trigger
additional benefits to the member-consumers particularly in the
rural barangays in terms of improve services and lower rates;

"WHEREAS, LEYECO V has to permanently establish a strong bond
with its member-consumers in order to achieve its plans and objec-
tives;

"WHEREAS, the position of General Manager of the Cooperative,
requires a person who is sensitive to the peculiar characteristics
of the place and people in the coverage; hence, it needs a man who
is familiar with the people and this is best fulfilled by one who
hails from within the coverage area of LEYECO V;

"WHEREAS, the incumbent Officer-In-Charge of LEYECO V, Mr.
Emiliano B. Codera, can best fulfill the above-mentioned requirement,
by virtue of the following qualifications and experience, to wit;

1. Residence for nineteen (19) years in Ormoc City;
2. Experience of fourteen (14) years as Billing Supervisor
of the Ormoc Electric Company which was taken over by
LEYECO V;
3. Experience as Billing Supervisor and Staff Assistant of
LEYECO V before his appointment by the Board of Direc-
tors, confirmed by the NEA, as Officer-In-Charge; and
4. Attendance in various seminars conducted by the NEA
which include, among others, the Cooperative Management
Course Phase I.

"NOW, THEREFORE, on motion of Kagawad Hermosilla, unanimously
seconded by all the rest of the Mga Kagawad present; be it

"RESOLVED, to request General Pedro G. Dumol, Administrator,
National Electrification Administration to confirm the appointment
of Mr. Emiliano B. Codera, Officer-In-Charge, Leyeco V as regular
General Manager of LEYECO V.
