RESOLUTION NO. 1813

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE
AMOUNT OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE
10% BARANGAY SHARE OF BARANGAY MATICAA TO BE MADE AVAIL-
ABLE FOR DEATH BENEFITS TO THE SURVIVING HEIRS OF THE LATE
LATE BARANGAY KALIHIM GUILLERMO SURIMA.

"WHEREAS, we are in receipt of Resolution No. 2, s. 1985
of the Sangguniang Pambarangay of Maticaa, this city, request-
ing an amount of P500.00 to be taken from its existing funds
for death benefits to the surviving heirs of the Late Barangay
Kalihim Guillermo Surima, who died on April 21, 1983;

"NOW, THEREFORE, on motion of Kagawad Bandalan, seconded by
Kagawad Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the
amount of Five Hundred Pesos (P500.00) from out of the 10% Baran-
gay share of Barangay Maticaa to be made available for death bene-
fits to the surviving heirs of the Late Barangay Kalihim Guillermo
Surima, who died April 21, 1983.

Pambarangay of Maticaa, all in Ormoc City.
