RESOLUTION NO. 1816

A RESOLUTION REQUESTING THE BATASANG PAMBANSA, THROUGH THE SPONSORSHIP OF ALL THE LEYTE ASSEMBLYMEN TO RESPECTFULLY PASS A RESOLUTION THAT, ORMOC CITY HIGH SCHOOL, ORMOC CITY BE NATIONALIZED SO THAT IT'S OPERATION AND IT'S BUDGET AND OTHER REQUIREMENTS WILL BE INCLUDED IN THE PRESENT DELIBERATION OF THE NATIONAL BUDGET FOR CALENDAR YEAR 1986,

"WHEREAS, the city government of Ormoc is very much aware of it's responsibilities in the operation, administration, as well as the maintenance of the Ormoc City High School;

"WHEREAS, due to the present economic crisis, the city government can not afford anymore to come up to a more realistic level of the salaries, allowances and other fringe benefits for the school's administrators and teaching staff;

"WHEREAS, the city government can not meet the high cost of all administrative expenses, including cost of repairs and maintenance of buildings, due to inadequacy of funds as a result of the present adverse economic conditions affecting the city;

"WHEREAS, for the best interest of all, parents, teachers and the student body of the Ormoc City High School, it is but just that a said school be nationalized so that teachers' salaries, allowances and other benefits would be at par or in equal level with the rest of the national high school teachers throughout the country; and, that fiscal matters affecting its operation shall by then become the national government's concern;

"NOW, THEREFORE, on motion of Kagawad Fiel, unanimously seconded by all the rest of the Mga Kagawad present; be it

"RESOLVED, to request the Batasang Pambansa, through the sponsorship of all the Leyte Assemblymen to respectfully pass a resolution that Ormoc City High School, Ormoc City be nationalized so that it's operation and it's budget and other requirements will be included in the present deliberation of the national budget for calendar year 1986;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency Ambassador Benjamin T. Romualdez of 1201 J.P. Laurel Street;




