RESOLUTION NO. 1822

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS, THRU THE MINISTER OF PUBLIC WORKS AND HIGHWAYS FOR FINANCIAL AND MATERIAL ASSISTANCE TO ORMOC CITY FOR THE PROSECUTION OF PRIORITY PROJECTS.

"WHEREAS, the local administration of Ormoc City envisions to have some developmental projects which are very much needed and necessary and which we believe would redound to the greatest benefits of our constituents;

"WHEREAS, the city desires to have the following projects:

- 1) Shore protection along barangays Alegria, Batuan and Punta;
- 2) Construction of Anilao river control;
- 3) Construction of Malbasag river control;

"WHEREAS, the finances of the city can not well afford to spend for these projects considering the huge financial requirements and the limited fiscal resources of the city;

"WHEREAS, Ormoc City intends to come up to the expectations of its constituents and that the only recourse now available to the city is to ask His Excellency President Ferdinand E. Marcos through the Minister of Public Works and Highways for financial and material assistance for the prosecution of these priority projects;

"NOW, THEREFORE, on motion of Kagawad Besabella, unanimously seconded by all the rest of Mga Kagawad present; be it

"RESOLVED, to earnestly request His Excellency President Ferdinand E. Marcos, thru the Minister of Public Works and Highways for financial and material assistance to Ormoc City for the prosecution of the priority projects;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency President Ferdinand E. Marcos; the Honorable First Lady and Human Settlements Minister, Madam Imelda Romualdez-Marcos; both of Malacañang; the Minister of Public Works & Highways; His Excellency Ambassador Benjamin T. Romualdez, 1201


