RESOLUTION NO. 1824

A RESOLUTION REQUESTING THE HONORABLE ACTING CITY MAYOR TO ASSIGN TWO (2) POLICEMEN DURING THE DAY AND TWO (2) IN THE EVENING AT THE ORMOG PUBLIC MARKET PERIMETER CONSIDERING THE ALARMING OCCURRENCE OF ROBBERIES AND THIEVERIES AND OTHER CRIMES, PETRATED THEREIN.

"WHEREAS, according to reliable information robberies, thieveries and other crimes had been rampant in the public market, bus and jeep terminals, despite our existing laws and ordinances to this effect;

"WHEREAS, if these rampant wrong-doings were left unchecked, certainly, it would create a bad image for our local administration and the safety of our citizenry would be jeopardized;

"NOW, THEREFORE, on motion of Kagawad Besabella, jointly seconded by Mga Kagawad Alfaro and Hermosilla; be it

"RESOLVED, to request the Honorable Acting City Mayor to assign two (2) Policemen during the day and two (2) in the evening at the Ormoc Public Market perimeter and bus and jeep terminals considering these alarming occurrences of robberies and thieveries and other crimes;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Station Commander, Ormoc City Police Station, the City Treasurer, and the Market Master, all in Ormoc City;

"CARRIED UNANIMOUSLY."
