RESOLUTION NO. 1825

A RESOLUTION REQUESTING THE CITY HEALTH OFFICER TO PLACE EIGHT (8) HOURS DUTY OF HIS SANITARY INSPECTORS TO CHECK ON THE SANITATION, CLEANLINESS AND ALSO THE SALE OF HOT MEAT KNOWN AS "MEJORAS" WHICH IS RAMPANT IN THE PUBLIC MARKET.

"WHEREAS, this august Body has been informed that there is much to be desired insofar as sanitation and cleanliness in the public market is concerned;

"WHEREAS, it has also come to the knowledge of this body that sale of "Hot Meat" is rampant in our public market;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly by Mga Kagawad Bandalan and Alfaro; be it

"RESOLVED, to request the City Health Officer to place eight (8) hours duty of his Sanitary Inspectors to check on the sanitation, cleanliness and also the sale of hot meat known as "Mejoras" which is noted to be rampant in the public market; Further the City Veterinarian is requested to act in coordination with the City Health Officer on this matter and that a report of performance in this regard is highly requested;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, City Health Officer, the City Veterinarian, and the Market Master, all in Ormoc City;

"CARRIED UNANIMOUSLY."
