RICARDO PALOMA THAT A PAL OFFICE BE OPENED IN ORMOC CITY.

"WHEREAS, the Sangguniang Panlungsod through Kagawad Bandalan, in

the attention of his colleagues the necessity of establishing booking of-
fice in Ormoc City for the convenience of the commuters in Ormoc City and
