RESOLUTION NO. 1831

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY SHARE OF BARANGAY CURVA TO BE MADE AVAILABLE FOR DEATH BENEFITS OF THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD TEODORICO IBON.

"WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 3, series 1985 of the Sangguniang Pambarangay of Curva, this city, requesting the amount of P500.00 to be taken from its existing funds for death benefits to the surviving heirs of the Late Barangay Kagawad Teodorico Ibon, who died on October 14, 1985;

"NOW, THEREFORE, on motion of Kagawad Alfaro, jointly seconded by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of FIVE HUNDRED PESOS (P500.00) from out of the 10% Barangay share of Barangay Curva to be made available for death benefits of the surviving heirs of the Late Barangay Kagawad Teodorico Ibon, who died on October 14, 1985;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the surviving heirs of the Late Barangay Kagawad Teodorico Ibon, and the Sangguniang Pambarangay of Curva, all in Ormoc City;
