RESOLUTION NO. 1832

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY
MAYOR TO ACCEPT BARANGAY 28'S DONATION OF 12 UNITS,
20-WATT FLOURECENT LAMPS FOR INSTALLATION IN STRA-
TEGIC AREAS IN SAID BARANGAY SUBJECT TO THE 250-WAT-
TAGE LIMITATION FOR EVERY BARANGAY PER RESOLUTION NO.
1149 DATED APRIL 20, 1982.

"WHEREAS, the Sangguniang Pambarangay of Barangay 28 in its
Resolution No. 6, series 1985, has signified the intention of the
Barangay to donate 12 units, 20-watt flourecent lamps for instal-
lation in their strategic area;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by
Kagawad Bandalan; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to
accept the donation of Barangay 28 of 12 units 20-watt flourecent
lamps for installation in their strategic area subject, however,
to the 250-wattage limitation for every barangay per Resolution
No. 1149 dated April 20, 1982, to be shouldered by the city, other-
wise, any excess thereof shall have to be borne by the barangay;
and

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Engineer, the City Treasurer, the Sangguniang Pambaran-
gay of Barangay 28, and the General Manager, Leyeco V, all i n
Ormoc City;
