RESOLUTION NO. 1936

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM
OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY
SHARE OF BARANGAY BOROC TO BE MADE AVAILABLE FOR DEATH BENEFITS
OF THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD
INOCENTES LUMAKAD.

"WHEREAS, this august Body is in receipt of Resolution No. 5,
series 1985 of the Sangguniang Pambarangay of Boroc, this city, request-
ing the amount of P500.00 to be taken from its existing funds for death
benefits of the surviving heirs of the Late Barangay Kagawad Inocentes
Lumakad, who died on October 25, 1985;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawad
Bandalan; be it

"RESOLVED, to authorize the City Treasurer to release the sum of
FIVE HUNDRED PESOS (P500.00) from out of the 10% Barangay share of Ba-
rangay Boroc to be made available for death benefits of the surviving
heirs of the Late Barangay Kagawad Inocentes Lumakad, who died on October
25, 1985;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
City Treasurer, the City Budget Officer, the surviving heirs of the Late
Barangay Kagawad Inocentes Lumakad, and the Sangguniang Pambarangay of
Boroc, all in Ormoc City;
