RESOLUTION NO. 1837

A RESOLUTION REQUESTING THE BUREAU OF INTERNAL REVENUE QUEZON CITY TO REVIEW THE COMPUTATION OF THE SHARE OF THE CITY OF ORMOC IN THE REGULAR AND SPECIFIC TAX ALLOTMENTS FOR CALENDAR YEARS 1984 and 1985.

"WHEREAS, the City of Ormoc had been receiving 25% annual increase in the internal revenue allotments since calendar year 1981;

"WHEREAS, on the basis of a 25% annual increase of the BIR regular internal revenue allotment, the City of Ormoc would have received P3,739,600.56, but since the City government received only P2,587,883.72 per our records, there is a deficiency of P1,151,796.84 for calendar year 1984;

"WHEREAS, the City of Ormoc has not received todate even a partial release of said deficiency of the BIR regular internal revenue allotment payable by the Treasurer of the Philippines for calendar year 1984;

"WHEREAS, similarly applying as basis a 25% annual increase of the BIR regular internal revenue allotment, the city government of Ormoc would have to receive the total amount of P3,739,600.56 for calendar year 1985;

"WHEREAS, our current actual monthly release is only P223,737.25 or an annual total of P2,684,847.00 for calendar year 1985, thereby leaving a deficiency of P1,054,752.86;

"WHEREAS, for current calendar year 1985, the City of Ormoc would have to receive a month specific tax (INFRA) allotment of P917,116.66 or annual total of P11,005,399.92 as per records of the BIR Accounting Division, Bureau of Internal Revenue, Quezon City;

"WHEREAS, the actual specific tax allotment received monthly by the city government is only P752,035.66 or a total of P9,024,427.92, thereby leaving a deficiency of P1,980,972.00.

"WHEREAS, in view of the tight financial condition of the city, it is requested that the deficiencies afore-mentioned be released as early as possible.


"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by Kagawad Mendola; be it




