RESOLUTION NO. 1843

A RESOLUTION REQUESTING THE MANAGEMENT OF LEYECO V TO INSTALL
POSTS AND ELECTRICAL WIRING THEREOF FROM SITIO CASANTULAN
TO SITIO SUBANG DAKO OF BARANGAY SAN JUAN, WITH AN ESTI-
MATED DISTANCE OF 720 METERS.

"WHEREAS, the road at Sitio Casantulan leading to Subang
Dako is dark during nighttime because of the absence of electri-
cal lighting;

"WHEREAS, if this situation is not attended to, no doubt this
would pose a danger to the people living nearby as bad elements
would take advantage of this dark places.

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by
Kagawad Fiel; be it

"RESOLVED, to request the Management of Leyeco V to install
posts and electrical wiring thereof from Sitio Casantulan to
Sitio Subang Dako of Barangay San Juan, this city with an esti-
mated distance of 720 meters;

"RESOLVED, FURTHER, to furnish a copy of this resolution
each to the City Treasurer, and Manager Leyeco V, and the Sanggu-
niang Pambarangay of San Juan;
