RESOLUTION NO. 1846

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO SIGN IN BEHALF OF THE CITY OF ORmoc A CONTRACT OF SALE WITH ATTY. FERMIN MAGLASANG ACQUIRING A PORTION OF ELEVEN (11) SQUARE METERS OF LOT NO. 1354 SITUATED AT AGUA DULCE STREET TRAVERSED BY ORmoc WATERWORKS PIPES.

"WHEREAS, the Ormoc City Waterworks pipes traversed a portion of Lot No. 1354, owned by Atty. Fermin Maglasang, covering an area of eleven (11) square meters more or less, situated at Agua Dulce Street, Ormoc City;

"WHEREAS, per recommendation of Engr. Nestor C. Penserga, Waterworks Superintendent II, Ormoc City, it is more economical to purchase said portion than by paying a yearly rental of TWO HUNDRED SIXTEEN (P216.00) PESOS;

"WHEREAS, the City Assessor recommends that the fair market value is ONE HUNDRED TWENTY-FIVE PESOS (P125.00) per square meter;

"WHEREAS, in this connection, it is imperative that the Honorable Acting City Mayor be authorized to sign for and on behalf of the City a Contract of Sale, acquiring the eleven (11) square meters portion of Lot No. 1354 traversed by Ormoc Waterworks pipes, at the price recommended by the City Assessor, Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Bandalan, be it

"RESOLVED, to authorize the Honorable Acting City Mayor to sign, in behalf of the City of Ormoc a Contract of Sale with Atty. Fermin Maglasang acquiring the eleven (11) square meters portion of Lot No. 1354 situated at Agua Dulce Street traversed by Ormoc Waterworks pipes at the price recommended by the Ormoc City Assessor;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Legal Officer, the City Engineer, the City Assessor, and Atty. Fermin Maglasang, Agua Dulce Street; all in Ormoc City;
