RESOLUTION NO. 1848

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY SHARE OF BARANGAY LINAO TO BE MADE AVAILABLE FOR DEATH BENEFITS OF THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD TEOFILA DECKER.

"WHEREAS, the Sangguniang Pambarangay of Linao in its Un-numbered Resolution, current series had requested for an appropriation of P500.00 to be taken from the existing funds of Barangay Linao for payment of death benefits of the family of the Late Barangay Kagawad Teofila Decker, who died on September 28, 1985.

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Torre Villas, and Bandalan; be it

"RESOLVED, to authorize the City Treasurer to release the sum of Five Hundred Pesos (P500.00) from out of the 10% Barangay share of Barangay Linao to be made available for death benefits of the surviving heirs of the Late Barangay Kagawad Teofila Decker, who died on September 28, 1985;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the Barangay Affairs Officer, the surviving heirs of the Late Teofila Decker, and the Sangguniang Pambarangay of Linao; all in Ormoc City;
