RESOLUTION NO. 1849

A RESOLUTION APPROVING RESOLUTION NO. 8, CURRENT SERIES OF THE SANGGUNIANG PAMBARANGAY OF ALEGRIA FOR INSTALLATION OF TWO (2) MERCURY LAMPS 80-WATT; ONE (1) ON THE POST FACING BARANGAY BATUAN AND ANOTHER ON THE POST BOUNDARY BETWEEN ALEGRIA AND BARANGAY PUNTA.
