RESOLUTION NO. 1850

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY SHARE OF BARANGAY DON POTENCIANO LARRAZABAL TO BE MADE AVAILABLE FOR DEATH BENEFITS OF THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD MARCELA MONTON.

"WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 9, current series, of the Sangguniang Pambarangay of Don Potenciano Larrazabal, requesting an appropriation of P500.00 to be taken from the existing funds of Barangay Don Potenciano Larrazabal for payment of death benefits of the surviving heirs of the late Barangay Kagawad Marcela Monton, who died on November 10, 1985;

"NOW, THEREFORE, on motion of Kagawad Bandalan, jointly seconded by Mga Kagawad Fiel and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of Five Hundred Pesos (P500.00) from out of the 10% barangay share of Barangay Don Potenciano Larrazabal to be made available for death benefits to the surviving heirs of the late Barangay Kagawad Marcela Monton, who died on November 10, 1985;

"RESOLVED, FURTHER to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the Barangay Affairs Officer, the surviving heirs of the late Marcela Monton, and the Sangguniang Pambarangay of Don Potenciano Larrazabal;
