A RESOLUTION FAVORABLY ENDORSING RESOLUTION NO. 14, CURRENT SERIES OF THE SANGGUNIANG PAMBARANGAY OF CABINGTAN, ORMOC CITY, TO THE REGIONAL HEALTH DIRECTOR, MINISTRY OF HEALTH FOR FAVORABLE ACTION.

"WHEREAS, the Sangguniang Pambarangay of Cabingtán in its Resolution No. 14, current series, has requested for an authority to use their own burial ground; at Barangay Cabingtán, Ormoc City;

"WHEREAS, this august Body has referred this resolution to the City Health Officer for his comment and recommendation;

"WHEREAS, the City Health Officer in his returned indorsement informed this Body that under Section 99, Chapter XXI of PD No. 856 (The Code on Sanitation of the Philippines), the Regional Health Director has the responsibility to act on applications for the establishment of burial grounds and close any burial ground which is a menace to public health;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Hermosilla; be it

"RESOLVED, to endorse favorably Resolution No. 14, current series, of the Sangguniang Pambarangay of Cabingtán, Ormoc City, to the Regional Health Director, Ministry of Health, Tacloban City, for favorable action;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Health Director, Ministry of Health, Tacloban City, the City Health Officer, and the Sangguniang Pambarangay of Cabingtán, all in Ormoc City;
