RESOLUTION NO. 1856

A RESOLUTION AUTHORIZING THE HONORABLE ACTING CITY MAYOR TO ALLOW
OPERATION OF AN ADDITIONAL 24 UNITS OF MOTORIZED TRICYCLES IN
THE CITY OF ORMOC.

"WHEREAS, Kagawad Torrevillas, in his capacity as Chairman on
Police, Fire & Public Safety and as Member of the Committee on Trans-
portation, has requested the Traffic Division of the Police Department,
this city, to conduct a traffic survey regarding the possibility of
increasing the number of motorized tricycles in order to alleviate the
problems of the riding public;

"WHEREAS, in the return survey report 49 out of 100 persons inter-
viewed in all walks of life favored for additional units and 48 against;
it is believed that an addition of twenty-four (24) units of motorized
tricycles will meet the demands and satisfy the riding public in the
different points of the city and barangays;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by
Kagawad Bandalan; be it

"RESOLVED, to authorize the Honorable Acting City Mayor to allow
the operation of an additional twenty-four (24) units of motorized tri-
cycles in the City of Ormoc;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the Ministry of Land Transportation, Ormoc Field
Office, and the Police Station Commander, all in Ormoc City;
