RESOLUTION NO. 1860

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR, MINISTRY OF AGRICULTURE & FOOD TO IMPOSE QUARANTINE AND OTHER MEASURES IN ORDER TO CONTROL THE SPREAD OF HORSE DISEASES WHICH IS PRE-VALENT IN ORMOC CITY AND NEIGHBORING MUNICIPALITIES.

"WHEREAS, examination of blood samples of horses performed by Manila doctors showed positive results of diseases of horses;

"WHEREAS, it is imperative that positive steps or measures be taken to control such horse diseases before it is too late and before it shall have affected a good number of horses in Ormoc City and, neighboring municipalities;

"WHEREAS, we bring this matter to higher authorities concerned f o r immediate solution even as we have taken our own controlling measures on the same;

"WHEREAS, we therefore ask the Regional Director, Ministry of Agriculture and Food, that certain quarantine measures be taken in order to check effectively the spread of the diseases;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, jointly seconded by Mga Kagawad Mendola and Alfaro; be it

"RESOLVED, to earnestly request the Regional Director, Ministry of Agriculture & Food to impose quarantine and other measures in order to control the spread of horse diseases which is prevalent in Ormoc City and neighboring municipalities;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Ministry of Agriculture & Food, Tacloban City, and the In-Charge, Ministry of Agriculture & Food, Ormoc City;

"CARRIED UNANIMOUSLY."
